RANGE RULES

WAIVER OF LIABILITY, ASSUMPTION OF RISK FOR PARTICIPATION, AND RELEASE FROM RESPONSIBILITY ("WAIVER & RELEASE") FORM

"OFSC" = Old Forge Sporting Clays, LLC, as well as its successors and assigns, affiliates, members, officers, employees, agents, insurers, and all other related parties.

"Premises" = including but not limited to the air, land, buildings, facilities, shooting stations, roads, etc. located at 7945 Long Reach Road, Providence Forge, VA 23140.

"Activities" = including but not limited to the following:

- a) the use of firearms i.e., shooting, loading, carrying, storing, cleaning, & handling of guns;
- b) the use of a mechanical trap to throw clays on the Premises;
- c) the observation and/or visitation of others on the Premises;
- d) the use of OFSC and/or non-OFSC golf carts, ATVs, guns and ammunition;
- e) the hosting of an event by an outside party for items a-d above and any & all other purposes;
- f) any & all other purposes.

"Equipment" = including but not limited to guns, golf carts/ATVs, protective gear, and ammunition whether rented/sold/supplied by OFSC or brought to the Premises by myself or others.

FOR AND IN CONSIDERATION of permitting the Undersigned to participate in Activities at OFSC and on its Premises, THE UNDERSIGNED, for herself, himself, her/his heirs, executors, administrators and assigns, UNDERSTANDS AND AGREES:

- 1) that there is a risk of serious injury or death if I participate in Activities on the Premises.
- 2) that I assume all risks of personal injury, death, damages, or losses of any type or for any reason that occur while on the Premises, taking part in Activities offered by OFSC or using the Equipment and Premises of OFSC whether or not such risks are known or unknown, or result from the negligent actions or non-actions of OFSC or the negligence of others who are on the Premises. Those risks include, but are not limited to, risks related to the discharge of firearms, the firing of live ammunition by myself and others and the design of and/or conditions of the Premises.
- 3) that I forever release OFSC from all liability for negligence of any type and waive any claims for personal injury, death, damages, or other losses of any kind, regardless of how or by whom such loss may be caused, which occur to me, my guests, or my property while upon the Premises, participating in Activities offered, or using the Equipment and facilities of OFSC.
- 4) that I forever release, indemnify, and hold harmless OFSC from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected Activities and with the discharge of firearms, the firing or ricochet of live ammunition by myself or others, presence at, conditions of, and use of the equipment and facilities located on the Premises or the design or condition of the equipment and facilities located on the Premises including, without limitation, the costs of court, attorney's fees or other costs or expenses incurred in connection with defending any such claim, demand or lawsuit.
- 5) that I accept all risks arising out of or relating to my participation in Activities and/or my use of Equipment and facilities, whether listed in items 1-4 above or not.
- 6) that I will read and abide by the OFSC course rules and regulations, as well as all other OFSC rules and regulations as they may be posted or presented by OFSC personnel. And, if I do not follow these rules and regulations, my permission to participate will be revoked, I will be asked to leave immediately, and any fees or charges that I paid will not be refunded.

OFSC's failure to exercise any of its rights under this Waiver & Release does not prevent OFSC from exercising such rights at a later date. This Waiver & Release contains the full and complete understanding of OFSC and the Undersigned with regard to its subject matter and supersedes all prior agreements and understandings, cannot be modified except in writing signed by both Undersigned and an authorized representative of OFSC, and is governed in accordance with the law of Virginia, without regard to its conflict or choice of law provisions. This Waiver & Release will continue in effect even after termination of Undersigned's presence at the Premises or participation in any Activities. An electronic or facsimile signature or acceptance of this Waiver & Release will have the same force and effect as an original, non-facsimile signature.
